<p>Heath & Wellness Facility <i>Second floor fitness equipment and counselor space to support physical, behavioral, & mental health services by reducing negative stigma and providing easy access and affordability to both counselor and health and wellness services.</i></p>	<p>\$500,000</p>
<p>Youth Development Area <i>2,400 sq ft program area designed for our youth and young adult populations inclusive of technology hub, climbing wall, group work space, hang out-lounge, games and more.</i></p>	<p>\$500,000 (secured)</p>
